**AMENDED STIPULATION
EXTENDING DEADLINE TO FILE
REQUEST FOR AGENCY ACTION**



On May 28, 2013, the Utah Division of Air Quality issued the Notice of Violation and Order to Comply in this matter ("NOV and Order"). Stericycle received the NOV and Order by certified mail on May 30, 2013. Pursuant to R305-7-303(5) and the terms of the NOV and Order, Stericycle had 30 days from receipt of the NOV and Order to file a Request for Agency Action ("RFAA") contesting the NOV and Order. The original 30 days would have expired on or about June 29, 2013. However, the parties wished to engage in resolution discussions before undertaking litigation of this matter. Accordingly, the parties, through their undersigned counsel, and pursuant to UAC R305-7-303(5), stipulated that Stericycle's deadline for filing the

RFAA was extended to July 31, 2013. The parties formalized this extension in the Stipulation Extending Deadline to File Request for Agency Action filed on June 19, 2013.

The parties have continued to engage in resolution discussions, but agree they need more time to exchange information to attempt to resolve this matter before undertaking litigation. As a condition of granting this further extension, DAQ requested and Stericycle agreed to attend weekly meetings either in person or by teleconference in order to advance resolution discussions. Accordingly, pursuant to UAC R305-7-303(5) and the parties' conference call of July 31, 2013, the parties stipulate to engage in weekly settlement meetings to conclude no later than August 29, 2013. The parties may schedule additional meetings or conference calls as necessary. In the event that the parties are unable to reach resolution by August 29, the parties further stipulate that Stericycle will have until August 30, 2013 to file a Request for Agency Action.
