Dear Shannon,

It is my pleasure to officially welcome Hexcel Corporation as a Partner in our Clean Utah program.

Your facility successfully met our compliance and EMS requirements. We have accepted your environmental improvement projects including:

1. Reduce plant-wide steam consumption by 10%.
2. Implement methylene chlorine recycling in labs.
3. Fully integrate plant-wide recycling program.

We request that you file an annual report documenting your progress on both projects in September of each year, starting in 2006. Once a project has reached its logical conclusion, you will need to propose others in order to maintain your Partner status.

As incentives, DEQ has agreed to your request for low priority for routine inspections. Currently, you are inspected annually by the Divisions of Air Quality and Water Quality. Based on your compliance record, the 2005 inspections will not occur. The next regular inspections will be in 2006. The facility must, however, maintain all recordkeeping and other requirements. Since the Division of Solid and Hazardous Waste inspects less frequently, no adjustments will be made to your RCRA inspection schedule.

We are currently exploring the possibility of your MACT-related request regarding MEK and the federal "once in, always in" policy. As we discussed, this is not something we are able to do at the State level so we will be discussing it with EPA. We will let you know what, if anything, we will be able to grant.

Designation as a Partner also entitles the your facility to use the Clean Utah logo in promotional and other materials. Please note that the rights to this logo apply only to the facility covered in the Clean Utah application.

DEQ will post information about your facility on our Clean Utah website. We are currently in the process of preparing a press release announcing your acceptance into the program. We also have a plaque we would like to present to you and your staff. Renette Anderson will be in touch with you to make arrangements.

I would like to extend an invitation to you to attend a meeting of the DEQ Quality Council in the near future. This will be an opportunity for our Executive Staff to hear more about your projects and to discuss issues of interest. We will be in contact soon to get you more details.

Again, welcome to Clean Utah. I am looking forward to our continued association.
