



Hello,

This message is being sent to all Community and Non-Transient Non-Community water systems and is a follow-up to [the message that I sent earlier this year](#). We will be sending systems a letter with this same information in case this email does not reach them.

EPA finalized the Lead and Copper Rule Revisions (LCRR) in December, 2021. The LCRR contains many changes but the top priority for all community and non-transient non-community water systems is completing and submitting initial service line inventories and lead service line replacement plans by the **October 16, 2024 deadline**. I wanted to provide some updates on resources the Division is preparing in order to assist systems with complying with those requirements:

- **Service Line Inventory Template Available:** All Community and Non-Transient Non-Community water systems must submit an initial service line inventory to the Division by October 16, 2024. We have published a service line inventory template on our [LCRR.utah.gov](https://LCRR.utah.gov) webpage under the 'Resources' tab. You can also click the following link to download the [Service Line Inventory Template excel file](#). Please make sure to read the introduction and instructions thoroughly. We, at the Division, are developing a portal that systems will use to submit and update inventories. If you complete them prior to the portal going "live", you may also submit your initial inventories by uploading them to WaterLink. We will make an announcement and provide instructions when the portal is ready to use.
- **Application for Funding Upcoming:** The Drinking Water Board has approved an expedited application process for systems seeking funding at or below \$100,000 to develop service line inventories and/or lead service line replacement plans. The Division will be issuing an application for this funding next month. Any applications for funding above this amount will go through the normal Drinking Water State Revolving Fund (DWSRF) process. - **Assistance for Small Systems RFP:** The Division of Drinking Water will be issuing a request for proposals in the coming days to hire one or more contractors to assist small water systems (population <10,000) with developing service line inventories and lead service line replacement plans. We will make an announcement to small systems about steps for receiving assistance once the contract has been finalized.

The Division of Drinking Water is here to support you as we all navigate this together. Be on the lookout for additional messages from the Division, and don't hesitate to reach out with any questions.
