Individuals on this list are also eligible to perform sampling. Certification is valid for a period of two years. An individual must renew prior to expiration of the original date of certification. This certification list is provided by the DEQ as an information item only. Placement of an individual on this list does not constitute an endorsement nor a preference among the contractors.
