Renewal of UIC Permit UTU-03-AP-173E18B

Purpose of Public Notice

The Utah Department of Environmental Quality is soliciting comments on its proposal to renew an Underground Injection Control (UIC) Class V Permit under the authority of the Utah Water Quality Act, Section 19-5-104(1)(I) Utah Code Annotated 1953 as amended, and the Utah Administrative Code R317-7. Under Section 19-1-301.5, effective May 8, 2012, a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the Director to fully consider the substance and significance of the issue. Background

Brigham City Corporation operates an aquifer recharge and recovery system as an integral part of their public water supply system. The purpose of the recharge and recovery system is to inject an excess supply of 4 to 6 million gallons per day of high quality water from six (6) Mantua Valley Springs during the winter months for subsequent withdrawal during the high use summer months. The spring water is chlorinated and fluoridated prior to injection into three (3) production wells.

Public Comments

Public comments are invited any time prior to **Friday, April 22, 2016**. Written comments may be directed to the Division of Water Quality, P.O. Box 144870, Salt Lake City, Utah 84114-4870. All comments received prior to Friday, **Friday, April 22, 2016**, will be considered in the formulation of final determinations to be imposed on the permit. A public hearing may be held if written requests are received within the first 15 days of this public comment period, that demonstrate significant public interest and substantive issues exist to warrant holding a hearing.
