PUBLIC NOTICE TO REISSUE A UPDES PERMIT

PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO DECLARE THE STATE OF UTAH'S INTENTION TO ISSUE A UTAH POLLUTANT DISCHARGE ELIMINATION SYSTEM (UPDES) PERMIT UNDER AUTHORITY OF THE UTAH WATER POLLUTION CONTROL ACT, SECTION 19-5-104(9) AND 107(2), UTAH CODE ANNOTATED 1953, AS AMENDED. SAID "PERMIT" REFERS TO THE UPDES PERMIT AND THE FACT SHEET STATEMENT OF BASIS (INCLUDING TOTAL MAXIMUM DAILY LOADS (TMDL'S)) IF APPLICABLE, AS PER SECTION 303(D) OF THE FEDERAL CLEAN WATER ACT (CWA)].

BACKGROUND

Chevron is a petroleum refinery facility located at 2351 North 1100 West, Salt Lake City. It has a Standard Industrial Classification (SIC) code 2911, for petroleum refining. As part of the renewal process, Chevron has completed and submitted an Effluent Screening Report to determine if additional effluent limits are needed to protect the beneficial use of the receiving water. The report demonstrates that the effluent from this facility will not cause or contribute to a violation of water quality standards. Therefore, the effluent limits, based on water quality standards, in the renewal permit are the same as in the previous permit. However, additional data is needed to address uncertainties associated with selenium and ammonia concentrations in the Northwest Oil Drain Canal and to further delineate the mercury and ammonia concentrations in the effluent.

Public comments are invited any time prior to the deadline of the close of business on November 25, 2014. After considering public comment the Utah Division of Water Quality may execute the permit issuance, revise it, or abandon it.
