Public Notice of Intent to Issue Operating Permit

**Purpose of Public Notice**

The Utah Department of Environmental Quality (DEQ) is soliciting comments on the intent to issue an operating permit described below under authority of Utah Administrative Code R317. Under Section 19-1-301.5, effective May 8, 2012, a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the Director to fully consider the substance and significance of the issue. The Operating Permit shall apply to Wastewater Treatment and Disposal Facilities owned and operated by Heber Valley Special Services District (HVSSD), Heber, Utah, solely for the treatment and disposal of wastewater generated by: Heber Valley Special Services District. The HVSSD was issued a Construction Permit from the Division of Water Quality (Division) on July, 18, 2011 for the construction of a new wastewater treatment system to increase their capacity. The new facility involves an aerator mechanical treatment plant with a Rapid Infiltration Basin (RIB) for disposal. Additionally, this permit requires specific monitoring and reporting for all facilities, including the treatment lagoons, land Application, RIB and specific ground water monitoring.
