Purpose of Public Notice

The Utah Department of Environmental Quality (DEQ) is soliciting comments on the request to renew a ground water discharge permit as described below. The ground water discharge permit is issued by the Director of the Division of Water Quality under authority of the Utah Water Quality Act, Section 19-5-106(g) Utah Code Ann. 1953, as amended and Utah Administrative Code R317-6. Under Section 19-1-301.5, effective May 8, 2012, a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the Director to fully consider the substance and significance of the issue. Kennecott Utah Copper LLC has requested renewal of the ground water discharge permit that covers operation of their Large and Small Bingham reservoir system located just south of the town of Copperton in Salt Lake County. The reservoir system consists of the desilting basin primarily used to remove silt and debris from storm water flow prior to entering Zones 1 and 2 of the large reservoir, and the small reservoir located north of the large reservoir. Each of the reservoirs may be utilized to contain storm water runoff from the mine and waste rock dumps, as well as ground water pumped as a result of remediation activities. Each reservoir is designed with leak detection sumps that are monitored weekly to detect compromises in the integrity of the pond liner, should they occur.
