THE PURPOSE OF THIS PUBLIC NOTICE IS TO SOLICIT PUBLIC COMMENT REGARDING SNYDERVILLE BASIN WATER RECLAMATION DISTRICT'S INTENTION TO SUBSTANTIALLY MODIFY ITS RULES AND REGULATIONS AS PART OF THEIR PRETREATMENT PROGRAM. THE RULES AND REGULATIONS HAVE BEEN REVIEWED AND ONCE THE PUBLIC NOTICE AND COMMENT PROCESS IS COMPLETED; IT IS THE DIVISION OF WATER QUALITY'S INTENTION TO FORMALLY APPROVE THESE MODIFICATIONS.

BACKGROUND

Snyderville Basin Water Reclamation District has modified its Industrial Pretreatment Program by re-evaluating its rules and regulations which apply to industrial users within Snyderville's service area. The modified rules and regulations may impact industrial users within Snyderville's service area.

PUBLIC COMMENTS

Public comments are invited any time prior to the deadline of the close of business on September 17, 2013. Written public comments can be submitted to: Jennifer Robinson, UPDES Engineering Section, Utah Division of Water Quality, P.O. Box 144870, Salt Lake City, Utah 84114-4870 or by email at: jenrobinson@utah.gov. After considering public comment the Utah Water Quality Director (Director) may execute the modifications, revise it, or abandon it.

A public hearing can be requested but must be filed during the 30 day comment period which will end on September 17, 2013 at the close of business. A request for a public hearing must be filed per the requirement of 40 CFR 403.11. After considering public comments the Director may approve, revise, or abandon the changes to Snyderville Basin's rules and regulations. The Director will not publish a notice of decision provided: Snyderville Basin's rules and regulations will be approved without any changes and no comments are received during the public comment period.
