PUBLIC NOTICE OF A UPDES PERMIT REISSUANCE

PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO DECLARE THE STATE OF UTAH'S INTENTION TO REISSUE A UTAH POLLUTANT DISCHARGE ELIMINATION SYSTEM (UPDES) PERMIT UNDER AUTHORITY OF THE UTAH WATER POLLUTION CONTROL ACT, SECTION 19-5-104(9) AND 107(2), UTAH CODE ANNOTATED 1953, AS AMENDED. SAID "PERMIT" REFERS TO THE UPDES PERMIT AND THE STATEMENT OF BASIS (INCLUDING TOTAL MAXIMUM DAILY LOADS (TMDL'S)) IF APPLICABLE, AS PER SECTION 303(D) OF THE FEDERAL CLEAN WATER ACT (CWA)].

BACKGROUND

This facility is a publicly owned wastewater treatment works. It treats wastewater by use of aerated bioreactors, settling and disinfection. Timpanogos Special Service District (TSSD) has a permitted biosolids composting program, and an approved pretreatment program. The design flow of TSSD is currently at 30.0 MGD. TSSD provides wastewater disposal services to the communities of Alpine, American Fork, Cedar Hills, Eagle Mountain, Highland, Lehi, Pleasant Grove, Vineyard, Suncrest, and Saratoga Springs, Utah.
