NOTICE OF PUBLIC COMMENT
CORRECTIVE MEASURES IMPLEMENTATION REPORT (CMIR)
SOLID WASTE MANAGEMENT UNIT (SWMU) 2
TOOELE ARMY DEPOT SOUTH (TEADS) AREA

The Director of the Division of Waste Management and Radiation Control invites comments from the public regarding the results of a cleanup action at SWMU 2 at TEADS. Historically, this area was used for disposal of munitions waste. TEADS recently completed removal of the waste, related materials and underlying contaminated soil and performed soil sampling after the removals. Based on the soil sampling data, TEADS proposes that SWMU 2 qualifies for unrestricted land use or no further action (NFA) as defined in R315-101 of the Utah Administrative Code.

The public comment period to receive comments on the no further action proposal will commence on June 28, 2016 and end on July 27, 2016.
