Low-Level Radioactive Waste Disposal License UT2300249**

The Utah Department of Environmental Quality, Division of Radiation Control (DRC) is requesting public comment regarding an initial decision by the Executive Secretary of the Utah Radiation Control Board to amend the EnergySolutions (Licensee) Low-Level Radioactive Waste Disposal License (RML UT2300249).

License Information

The proposed License amendment makes changes to License Conditions 10.E and 85.C. Specific changes are 1) Language has been added to License Condition 10.E to authorize sealed sources used for purposes identified in License Condition 9.I and 9.J to be stored and used on all property owned by the Licensee at their Clive Facility. The property is located in Sections 29, 32 and parts of Sections 28 and 33 in Township 1 South, Range 11 West and parts of Sections 4, 5, and 6 Township 2 South Range 11 West, Salt Lake Base Meridian (SLBM); 2) The language in License Condition 85.C was removed because the language is required by rule R313-19-34(9) and replaced by the word *Reserved*; and 3) several grammatical and formatting errors were corrected throughout the RML. A draft License Amendment with Statement of Basis describing the License change is available for review and/or copying between 8:00 a.m. and 5:00 p.m., Monday through Friday, at the address listed below.
