The Utah Department of Environmental Quality, Division of Radiation Control (DRC) is requesting public comment regarding an initial decision by the Director of the Utah Division of Radiation Control to amend the EnergySolutions (Licensee) Low-Level Radioactive Waste Disposal License (RML UT 2300249) and Ground Water Quality Discharge Permit (No. UGW450005).

License Information

The proposed License amendment makes changes to various License Conditions throughout the Radioactive Material License and various changes throughout the Groundwater Permit. Specifically, the license and permit changes address the proposed combination of the existing separate disposal embankments into a single embankment to be designated as the Class West embankment. The new Class A West embankment will encompass the footprints of the existing Class A and Class A North embankments. Part of this proposal also withdraws the Class A South/11e(2) embankment design changes submitted in January 2008.

A Safety Evaluation Report (SER), draft License along with a Statement of Basis and draft Groundwater Permit describing the License and Permit change(s) are available for review and/or copying between 8:00 a.m. and 5:00 p.m., Monday through Friday, at the address listed below. In addition to the initial and subsequent documents related to this proposal that have been available to the public throughout the review process, the draft License and Permit, Statement of Basis, and SER are also available on the Division website at: www.radiationcontrol.utah.gov/EnSolutions/licamends.html

A forty-five-day public comment period will commence on June 12, 2012 by publication of this notice on the Division of Radiation Control website, and distribution by an electronic mail server. In addition, this notice will be published in the Salt Lake Tribune, the Deseret News, and the Tooele County Transcript-Bulletin.

Under Utah Code Ann. Section 19-1-301.5, a person who wishes to challenge a Permit Order (permit/license amendment approval) may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the director to fully consider the substance and significance of the issue.

Written comments will be accepted if received by the end of business on July 26, 2012. Written comments may be directed to name and address listed above, or by email to radpublic@utah.gov. Comments sent in electronic format should be identified by putting the following in the subject line: Public Comment on Class A West Amendment. All comments received within the comment period will be considered for inclusion in the final modified License.

A hearing to receive public comments will be held July 17, 2012, beginning at 5:00 p.m., at the Tooele County Building, 47 South Main, Tooele, Utah.
