NOTICE OF PUBLIC COMMENT Juab Rural Development Agency Landfill Draft Permit Renewal

The Director of the Division of Waste Management and Radiation Control is seeking public comment on a request by the Juab Rural Development Agency to renew the solid waste permit for its Class II landfill at the existing site approximately 4.8 miles west of Nephi, south of SR-132. The permit renewal application has been reviewed for compliance with the Solid Waste Permitting and Management Rules and a draft permit has been prepared. The Director is soliciting comments on the Draft Permit.

The public comment period to receive comments on the draft permit will commence on September 14, 2016 and end on October 17, 2016.

All documents included in comments should be submitted as ASCII (text) files or in pdf format.

Under Utah Code Section 19-1-301.5, a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the Director to fully consider the substance and significance of the issue.
