PUBLIC NOTICE OF RENEWAL OF A UPDES PERMIT

PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO DECLARE THE STATE OF UTAH'S INTENTION TO REISSUE A UTAH POLLUTANT DISCHARGE ELIMINATION SYSTEM (UPDES) PERMIT UNDER AUTHORITY OF THE UTAH WATER QUALITY ACT, SECTION 19-5-104 AND 107, UTAH CODE ANNOTATED 1953, AS AMENDED. SAID "PERMIT" REFERS TO UPDES PERMIT AND THE STATEMENT OF BASIS (INCLUDING THE TOTAL MAXIMUM DAILY LOADS (TMDL'S)) IF APPLICABLE, AS PER SECTION 303 (d) OF THE FEDERAL CLEAN WATER ACT (CWA).

BACKGROUND

The Moroni City Water Reclamation Facility (MWRF) consists of the following unit processes: mechanical screen, primary clarifier, pre-aeration basin then to the membrane bioreactor system with UV disinfection. The MWRF permit consists of biosolids and storm water components included with the standard permit. The facility has been in service since 1974 with a design capacity of 1.1 Million Gallons per Day.
