PURPOSE OF PUBLIC NOTICE

THE PURPOSE OF THIS PUBLIC NOTICE IS TO DECLARE THE STATE OF UTAH'S INTENTION TO RENEW A UTAH POLLUTANT DISCHARGE ELIMINATION SYSTEM (UPDES) PERMIT UNDER AUTHORITY OF THE UTAH WATER QUALITY ACT, SECTION 19-5-104 AND 107, UTAH CODE ANNOTATED 1953, AS AMENDED. SAID "PERMIT" REFERS TO UPDES PERMIT AND THE STATEMENT OF BASIS (INCLUDING THE TOTAL MAXIMUM DAILY LOADS (TMDL'S)) IF APPLICABLE, AS PER SECTION 303 (d) OF THE FEDERAL CLEAN WATER ACT (CWA).

BACKGROUND

Nucor's Plymouth facility is a non-integrated steel mill (SIC Code 3312) which produces approximately one million tons of structural steel products annually. The principle process at Nucor Steel involves two Electric Arc Furnaces for melting scrap metal, the molten metal is then continuously cast into billets and the billets are directed to one of the two hot rolling mills for shaping into final products. There are wells that product the process water and culinary water at the facility. One well has water of a high quality that no other treatment is necessary for use a culinary water supply and also for water needed for the steel mill process. As long as this well is producing water there will be no discharge.
