# **Executive Summary**

#### **Need for Survey**

Recycling prevalence in Utah is growing, and it is a common media topic with some counties recently beginning or discussing curbside collection programs. Government agencies need to know how citizens feel about recycling so appropriate plans and decisions can be developed.

#### **Project Overview**

The DSHW worked with Dan Jones and Associates to design and conduct a statewide phone survey on recycling attitudes and actions. Calls were completed in August 2008, and there were 803 respondents (76% from urban areas and 24% rural) for a total error rate of  $\pm 3.5\%$ .

Respondents were 51% female and 49% male. Politically, 49% considered themselves Conservative, 32% Moderate, 12% Liberal, and 7% refused. Most respondents (91%) owned homes, 64% lived in their community for over 10 years, and 98% owned vehicles.

#### **Analysis of Results**

Support for recycling is extremely high in Utah, across the demographic categories, with 87% of respondents saying it is important. Support for recycling has risen with 94% saying their attitude is more positive than five years ago, and 89% feel their community should have a recycling program. Access to recycling has improved, but 66% of respondents want more, and only 43% have access to Household Hazardous Waste (HHW) drop-off sites. Most (66%) are willing to pay to have electronic equipment recycled. The percent of respondents who change vehicle oil at home and need to recycle it is low (< 20%), but many respondents said they may change their own oil in the future. The possibility more people may decide to change their oil is a different result than previous studies, and it may be due to increasing costs and current economics. Based on comments, reducing recycling fees and having private industry involvement are desires for many residents. Also, requests for more glass recycling and more recycling programs over State controlled, but many comments indicate a desire for State assistance or oversight if it can help the programs be more efficient.

#### **Recommended Collaborative Action for State and Local Government and Private Business**

- Increase recycling access (curbside or convenient drop-off locations) and keep it simple.
- Improve availability to glass, HHW, and electronic collection programs.
- Provide additional recycling information to residents and keep it up-to-date.
- Make recycling as cost effective as possible to keep fees to a minimum. Emphasize that recycling start up costs may help reduce long-term waste disposal costs and resource use.
- Coordinate the recycling activities of State and local governments and private business.

### Used Oil and Recycling Survey - Conducted: July-August 2008 for State of Utah, Dept. of Environmental Quality, Division of Solid and Hazardous Waste (DSHW) – Survey Area: State of Utah

### Abstract

The initial plans to conduct a survey were developed as part of the DSHW Used Oil Program's desire to collect information on trends and activities associated with do-it-yourselfers (DIYer). DIYers are people who change their vehicle oil rather than taking vehicles to a service center. Since 1993, used oil has been collected and recycled as part of the Used Oil Program, and the survey was needed to determine if DIYer trends were changing. Some trends of interest included monitoring the percentage of DIYers out of all vehicle owners, what DIYers were doing with their used oil, how often vehicle owners either changed their oil or had it changed, what oil change intervals were based on, and where DIYers were taking their used oil.

While planning the used oil survey, the DSHW discovered general recycling questions could be included without a significant time or cost increase. The DSHW felt there was a significant need to gather general recycling information because of increased interest by Utah counties to add to or develop recycling programs. Also, the DSHW received many calls from citizens wondering what to do with items such as old computers, rechargeable batteries, and household hazardous waste (HHW) items. Information was not available as to how the majority of Utah citizens actually felt about these recycling related issues, so the survey questions were formulated to provide county and State officials a better understanding. One important survey requirement was obtaining at least 20% of the responses from rural areas. This was included to demonstrate any differences in attitudes, activities, or needs of rural versus urban areas. Then, based on the outcome, the most appropriate recycling related planning and decisions could be developed.

Dan Jones and Associates, a Utah based market research and public opinion firm, conducted the telephone survey during July and August 2008, and their final report was completed in September. The survey results showed a high level of support for recycling in Utah, and the results provided information on respondents' preferences and concerns. The general recycling results were more supportive of recycling than expected, and this support was across the demographic category ranges. The used oil related results were mostly in line with expectations except for the possibility the number of DIYers may increase in the future. This would reverse a decreasing trend over the last couple decades. This possible change could be due to current economic conditions causing people to consider working on their vehicles to save money.

Information provided by the survey results could be used by the DSHW, local government officials, and private industry to support, develop, expand, or modify recycling programs. Some recommendations for collaborative actions, in response to the results, were included on the "Executive Summary" page.

#### Question 44: Do you have any general comments on recycling you would like to add?

- One of the things that we recycle, I think get junked, and I think that they should have a strong program that is monitored to make sure that it really gets recycled!
- Only that I would like to know that it actually takes place. Now my wife separates these things into two barrels, but we never really know what happens. Years ago, there was a recycling company that was just taking the recycling to the dump. I'd like to see some investigation, or something, to tell me it's being done.
- Only that if it were more available, I would take advantage of it. I think that if it was as convenient as it is in Europe, I think much more people would do it.
- Our city is in its process of getting recycling, and I will be able to participate.
- Our city---their recycling program has pickup twice a month. They skipped me 50% of the time, which left them to come by once a month. It just didn't work out for me.
- Our community is too small.
- Our daughter lives in Park City, and they recycle EVERYTHING. That's where the materials that we can't recycle here (like glass) go. She takes glass, plastic bags, plastic containers, etc. They have a wonderful recycling center up there. We're in the dry cleaning business, so she takes plastic bags up there---a whole carload every week---to be recycled.
- Paint should be recycled.
- People will use it, if it's available
- Personally, I think I would rather have a private company doing the recycling instead of the state. In California that is what they did, so you would always know the cost, which you don't know if the state (or county) controlled it.
- Provo City always has something in the paper to keep public informed. I think they are doing a good job.
- Rather than recycling, I think we should not have to use things. The wrappings of everything are filling up the landfills. I wish you could refill your laundry bottle at the store instead of buying a new bottle to throw away. I'd like to see legislation against the packaging of things, rather than us having to recycle it.

- The blue bins are an excellent idea, and we should have had this a long time ago. I think it's really helping the environment. I would like to have possibly two blue bins. I love recycling.
- The city of Salt Lake does not provide recycling options for businesses on alleys, or in condos. They have it all around us, just not here because our trash disposal is in an alley. I've brought it up to the city council, I've brought it up to the Sanitation Department and have been ignored.
- The city, county, and state should do more to try and promote it.
- The community should make it a little easier to recycle a broader variety of things.
- The computer companies should have to absorb the cost of recycling programs, since they profit from this.
- The county should collect glass. They collect everything else, and there's a lot of glass going into the landfill.
- The grand majority of recycling is a farce. It costs more money and resources to create new products. It should be composted and not recycled into paper.

The more the better. I think some easy public place should be set up for fluorescent light bulbs.

- There's been some negative stuff about the computer and electronic items that they are taken to India, and the kids take it apart and burn it, so I would like to know what the real answer is.
- They need to get glass recycling.
- They need to have a place that can drop off hazardous waste locally, rather than just in Salt Lake. They only offer it once a year, which is too long of a wait. It should be available all year locally.
- They need to have it more available here.
- They need to increase recycling from every week to every other week. We still aren't recycling glass here. In Pennsylvania, they started 20 years ago and Utah still isn't. I'm surprised they don't recycle landscaping waste, like trees or bushes.
- They need to set up garbage cans for recycling, especially hazardous materials.
- They should have a better system to recycle old electronics.
- They should recycle glass.
- They take the bins out for paper and plastic, but it would be nice if there was one for glass and tin cans. It puts back money for recycling those items. Centers aren't well-known by the communities.
- They're depending on the public to pay for this, and it's just not happening.
- Tooele County doesn't have enough opportunities for recycling. I would like to see more out here.
- Utah really needs to get it going because they don't have a very good recycling program, and I think it's very important. The US is polluting a lot, and people should be more aware.
- Wal-Mart takes plastic and plastic bags.
- We could add glass to the pickup.
- We don't recycle glass. I would be interested if our community did that, too.
- We had recycling in California. If you recycled---if they came and dumped your three bins each week, you would get a credit on your utilities. Here, I have to pay, so that's why I don't do it.
- We have blue containers. They come every other week, which makes it hard. I wish they would come every week.
- We have the blue bins at our house, and it has increased my recycling, makes my trash a lot less. Otherwise, I'd throw it away. It's a good program.
- We just need more of it.

- We just need to be doing way more of it. The city shouldn't be charging to do it in addition. It costs me extra to recycle, and it should be free.
- We just need to do more.

We need it in san Juan County. It is real important.

We need more availability.

- We need more education on it.
- We need more recycling places down here in St. George, where can I take my water here. There is no information on where to take it. What can we take to the landfill and what can't we?
