**NOTICE OF PUBLIC COMMENT
PERMIT RENEWAL
BEAVER COUNTY CLASS I LANDFILL**

Beaver County Solid Waste District Number 5 has asked for a permit renewal for the Beaver County Class I landfill located west of Beaver, Utah. The proposed permit renewal for the Class I landfill has been reviewed and determined to be complete and is in compliance with the Utah Solid Waste Permitting and Management Rules. This permit renewal allows the facility to continue to operate the Class I landfill for another ten years after the permit renewal has been approved. The public comment period for the permit renewal begins on July 5, 2019 and will end on August 5, 2019.
