The Division of Waste Management and Radiation Control (DWMRC) is proposing to enter into a Stipulation and Consent Order (SCO) with Clean Harbors Aragonite, LLC. (CHA) to resolve a notice of Violation (NOV) issued on March 26, 2021.

A 30-day public comment period to receive comments on the proposed SCO will commence on December 6, 2021, and end at 5 p.m. on January 4, 2022.
