On March 11, 2022, Clean Harbors Aragonite (Aragonite) submitted an application to renew their RCRA Part B operating permit which was due to expire on September 28, 2022. As part of their permit renewal application, Aragonite requested that duplicate requirements between their RCRA permit and MACT be removed from their RCRA permit. In evaluating Aragonite's permit renewal application, the Division of Waste Management and Radiation Control (Division) considered which operating requirements should be removed because they were duplicative with MACT requirements, and which operating requirements could not be removed because they were required as part of Aragonite's TSCA PCB Coordinated Approval. Based on this evaluation, the Division has prepared a Draft of the new RCRA Part B permit.

A 45-day public comment period to receive comments on the draft permit will commence on Thursday, March 30, 2023, and end at 5 p.m. on Monday, May 15, 2023.

A public hearing has been scheduled at 6:00 pm on Wednesday, May 3, 2023 at the Multi-Agency State Office Building, (DEQ Board Conference Room #1015), located at 195 North 1950 West, Salt Lake City, Utah 84116.
