Clean Harbors Aragonite – Class 3 Permit Modification Request  
Authorization to Accept and Manage Additional Compressed Gas Waste Types  
UTD 981 552 177

On August 26, 2022, Clean Harbors Aragonite (Aragonite) submitted a Class 3 permit modification request seeking approval to accept and manage additional types of compressed gas wastes at the Clean Harbors hazardous waste incineration facility located at Aragonite in Tooele County, Utah.

Currently, the Aragonite facility is authorized to accept and manage flammable and corrosive materials in compressed gas cylinders and tankers. The facility can also accept compressed gas cylinders and tankers containing cryogenic fluids but may not feed these to the incinerator. This modification request seeks approval to add oxidizing and toxic materials in compressed gas cylinders and tankers, as defined in the International Fire Code, as acceptable waste types for management at the Aragonite facility.

The Aragonite facility is a commercial hazardous waste incinerator that has a state of Utah hazardous waste permit to manage a wide variety of wastes including hazardous wastes, PCBs, industrial wastes, and infectious wastes. The facility is designed to handle high and low BTU liquid wastes, sludges, bulk solids, compressed gas cylinders and tankers and containerized wastes. Supporting permitted waste storage at the facility includes bulk liquids, bulk solids, and containers. The facility is located 2.5 miles south of I-80 at the Aragonite exit (Exit #56).

The Division of Waste Management and Radiation Control has reviewed the Class 3 modification request to add additional types of compressed gas waste to the list of wastes acceptable for management at the Aragonite facility and has determined the request to be complete and containing sufficient information to issue a draft approval. A draft approval outlining the changes to the Aragonite hazardous waste permit authorizing the acceptance and management of oxidizing and toxic compressed gas wastes in cylinders and tankers at the Aragonite facility has been issued and is available for review during the public comment period.

A 45-day public comment period to receive comments on the draft decision to approve additional compressed gas waste types as acceptable for management at the Aragonite facility will commence on Thursday, October 12, 2023, and end at 5:00 p.m. on Monday, November 27, 2023. A public hearing has been scheduled at noon on Monday, November 20, 2023, at the offices of the Division of Waste Management and Radiation Control, 2<sup>nd</sup> Floor of the Multi-Agency State Office Building, Anasazi Conference Room #2122, located at 195 North 1950 West, Salt Lake City, Utah 84116.
