Proposed Stipulation and Consent Order with Clean Harbors Aragonite, LLC. UTD 981 552 177

The Division of Waste Management and Radiation Control (Division) is proposing to enter into a Stipulation and Consent Order (SCO) Number 2210117 with Clean Harbors Aragonite, LLC. (CHA) to resolve a Notice of Violation and Compliance Order (NOV/CO) Number 2205051 issued on June 24, 2022.

A 30-day public comment period to receive comments on the proposed SCO will commence on Thursday, November 2, 2023 and end at 5 p.m. on Friday, December 1, 2023.
