Contract Environmental, Inc. has submitted an application for a permit renewal for the Contract Environmental Class V Landfill. The facility as described in this Permit currently operates a 160 acre Asbestos and Construction/Demolition landfill and oil field exploration & production waste soil land farm facility. The permit application for renewal of the Class V Landfill has been reviewed and determined to be complete and in compliance with the Utah Solid Waste Permitting and Management Rules. The Director is now seeking public comment on the draft permit.

The 30-day public comment period to receive comments on the draft permit will commence on June 4, 2020 and end on July 6, 2020.
