AMENDMENT NO. 1

TO

**MIXED WASTE
CLOSURE AND POST-CLOSURE
STANDBY TRUST AGREEMENT**

This Amendment No. 1 (the "Amendment") to the Mixed Waste Trust Agreement dated September 20, 2013 (the "Agreement" or "Trust") is entered into as of March 10, 2017, by and between EnergySolutions, LLC, a Utah limited liability company (the "Grantor") and Zions First National Bank (the "Trustee").

WHEREAS, there are a few minor administrative changes that need to be made to the Agreement as documented in this Amendment No. 1;

NOW, THEREFORE, the Grantor and the Trustee agree as follows:

1. The last sentence of the paragraph at the top of page 6 of the Agreement is hereby deleted and replaced with the following sentence:

"The parties below certify that the wording of this Agreement is identical to the wording specified in Utah Administrative Code R315-264-151(a)(1) as such regulations were constituted on the date first above written."

2. Christian Robinson, Controller is hereby deleted as a Signatory for Grantor on Schedule A and Exhibit A.

“Zions Bank, a division of ZB, National Association”


Except as amended above, all other terms and conditions of the Agreement remain unchanged and are in full force and effect.
