The Director of the Division of Waste Management and Radiation Control invites comment from the public on a draft Site Management Plan (SMP) developed by Chasebrook Company, 154 Myrtle Avenue, Suite 303, Murray, Utah. The SMP includes activity use limitations and future actions needed to manage the soil and groundwater contamination present at the Former Henries Dry Cleaner Site in Millcreek, Utah. The property is also required to implement an Environmental Covenant that will be recorded in the Salt Lake County Recorder's Office, after approval of the SMP.

The public comment period to receive comments on the SMP will commence on June 11, 2019 and end on July 10, 2019. A public hearing may be held if, within 15 days of publication of this notice, a request is made to the Director in writing which meets the requirements of UAC R315-311-3.
