A Site Management Plan (SMP) for The Huxley Development in Salt Lake City, Utah has been submitted to the Division of Waste Management and Radiation Control. The SMP outlines methods and actions that will be taken to mitigate risk and manage exposures at the site from former spills of tetrachloroethylene (PCE) and benzene.

A 30-day public comment period to receive comments on the SMP will commence on Monday, May 29, 2023 and end at 5 p.m. on Wednesday, June 28, 2023.
