A Site Management Plan (SMP) for the Wasatch Pallet Site in Spanish Fork, Utah has been submitted to the Division of Waste Management and Radiation Control. The SMP outlines methods and actions that will be taken to mitigate risk and manage exposures at the site from former spills of polycyclic aromatic hydrocarbons such as benzo(a)pyrene, benzo(a)anthracene, naphthalene, and others from coke processing in the 1980s through the mid-2000s.

A 30-day public comment period to receive comments on the Site Management Plan will commence on Monday, July 17, 2023 and end at 5 p.m. on Tuesday, August 15, 2023.
