The Division Waste Management and Radiation Control (Division) is proposing to enter into a Stipulation and Consent Order No. 2207086 with Utah State University (USU) to resolve Notice of Violation and Compliance Order No. 2108087 without further administrative or judicial proceedings. USU will pay a monetary penalty of \$2,840.90, while \$25,568.10 may be credited toward the total penalty of \$28,409.00 if USU completes a supplemental environmental project (SEP) related to the installation of solar panels on an existing parking garage at Utah State University. This SEP is expected to increase green electrical generation capacity by 40,460 kilowatt hours per year, which equates to approximately 53 pounds per year reduction in PM<sub>10</sub> indirect emissions associated with energy use. Fifty cents will be applied toward the credit amount for every SEP dollar spent by USU.

A 30-day public comment period to receive comments on proposed Stipulation and Consent Order No. 2207086 will commence on Tuesday, October 10, 2023 and end at 5 p.m. on Wednesday, November 8, 2023.
