NOTICE OF PUBLIC COMMENT ON  
DRAFT Permit  
Intermountain Generating Facility  
Coal Combustion Residual (CCR) Landfill and Surface Impoundments

Intermountain Power Agency (IPA) submitted a permit application for the Intermountain Generating Facility Coal Combustion Residual (CCR) Landfill and Surface Impoundments located approximately 14 miles north of Delta, Utah in Millard County. The proposed permit application has been reviewed and has been determined to be complete and in compliance with the Utah Solid Waste Permitting and Management Rules. This permit allows the facility to operate three CCR units (the CCR Landfill and two CCR Surface Impoundments) for ten years after the permit has been approved and signed. The Director of the Division of Waste Management and Radiation Control is seeking public comment on the DRAFT Permit. The CCR units will receive site-generated non-hazardous industrial CCR waste from the Intermountain Generating Facility.

The public comment period on the DRAFT Permit begins August 20, 2020 and will end September 18, 2020. If a public hearing is warranted, a date and time with information will be issued.

All documents included in comments should be submitted as ASCII (text) files or in pdf format.

Under Utah Code Section 19-1-301.5 a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the director to fully consider the substance and significance of the issue.
