NOTICE OF PUBLIC COMMENT ON
Manila Class II Landfill

Manila Town has submitted an application for a permit renewal for the Manila Class II Landfill located approximately two miles south of Manila, Utah. The application renewal for the Class II landfill has been reviewed and determined to be complete and in compliance with the Utah Solid Waste Permitting and Management Rules. A draft permit has been prepared which allows the facility to continue to operate the Class II landfill for ten years after final approval. The Director of the Division of Waste Management and Radiation Control is now seeking public comment on the Draft Permit.

The public comment period to receive comments on the Draft Permit will commence on January 15, 2020 and end on February 14, 2020.
