The Director of the Division of Waste Management and Radiation Control is seeking comment on a request from Millard County to renew the Fillmore Class IVb Landfill permit. The permit renewal request has been determined to be compliant with the Utah Solid Waste Permitting and Management Rules. A draft permit has been prepared.
