Monticello City has submitted a permit renewal application to continue operations of a Monticello Class IVb Construction and Demolition Landfill located east of Monticello in San Juan County. Class IVb landfills accept construction and demolition waste as defined in R315-301-2(17). The Permit application has been reviewed by the Division of Waste Management and Radiation Control for compliance with the Solid Waste Management Rules and a draft permit has been prepared by the Director. The Director is soliciting comments on the draft permit in relation to its compliance with the Solid Waste Management Rules prior to final action by the Director.

The public comment period to receive comments on the draft permit will commence on November 21, 2019 and end on December 20, 2019.
