Pursuant to the Utah Solid and Hazardous Waste Act, 19-6-101, et. seq., Utah Code Annotated 1953, as amended, and the regulations promulgated by the Waste Management and Radiation Control Board, codified in the Utah Administrative Code R315, and pursuant to the Solid Waste Disposal Act, 42 U.S.C. 3251 et. seq., as amended by the Resource Conservation and Recovery Act of 1976, 42 U.S.C. 6901 et. seq., and the Hazardous and Solid Waste Amendments of 1984 (HSWA), a permit is issued to Nexeo Solutions, LLC (hereinafter referred to as the Permittee), to operate a hazardous waste storage facility located at the Clearfield Freeport Center Building K-12, Davis County, Utah at latitude 41°05'25" North and longitude 112°01'06" West.

The Permittee shall comply with all the terms and conditions of this Permit. The Permit consists of Modules 1 through 3 and Attachments 1 through 11. The Permittee shall also comply with all applicable State rules, including R305-7, R315-101, R315-124, R315-260 through R315-270, and R315-273.

Applicable rules are those that are in effect on the date of issuance of this permit and any self-implementing provisions and related rules that, according to the requirements of HSWA, are automatically applicable to the Permittee's hazardous waste management activities, notwithstanding the conditions of this permit.

This permit is based on the premise that the information submitted in the original permit application, dated December 12, 1996, as modified by subsequent amendments, permit modification requests received throughout the term of the original permit; the permit renewal application received February 8, 2007, as modified by subsequent amendments and permit modification requests received throughout the term of the permit; and the permit renewal application received April 18, 2017, is accurate. The Permittee's failure in the application or during the permit issuance process to disclose fully all relevant facts, or the Permittee's misrepresentation of any relevant facts at any time, may be cause for the termination or modification of this permit, the initiation of enforcement action, including criminal proceedings, or any combination of these remedies. The Permittee shall inform the Director of the Division of Waste Management and Radiation Control of any deviation from or changes in the information on which the application was based which would affect the Permittee's ability to comply with the terms and conditions of this permit. The Director will enforce all terms and conditions of this permit. Any challenges to any condition of this permit shall be pursuant to R305-7 of the Utah Administrative Code and Utah Code Section 19-1-301.5.

This permit is effective as of September 25, 2018, and shall remain in effect until September 25, 2028, unless revoked and reissued pursuant to R315-270-41, terminated pursuant to R315-315-43 or continued in accordance with R315-270-51 and the conditions of this permit.
