NOTICE OF PUBLIC COMMENT

Payson City Landfill Solid Waste Permit Renewal

The Director of the Division of Waste Management and Radiation Control is seeking public comment on a request by Payson City to renew the solid waste permit for its Class V landfill at the existing site approximately 2.5 miles west of Payson City. The permit renewal application has been reviewed for compliance with the Solid Waste Permitting and Management Rules and a draft permit has been prepared. The Director is soliciting comments on the Draft Permit. Class V landfills are commercial landfills that receive nonhazardous solid waste including municipal waste and construction/demolition waste.

The public comment period to receive comments on the draft permit renewal will commence on December 28, 2017 and end on January 29, 2018.
