Rio Tinto Kennecott Utah Copper submitted a permit application for Smelter Refuse Class IIIb Landfill located south of the Rio Tinto Kennecott Utah Copper Smelter facility in Salt Lake County, Utah. The landfill will continue to receive non-hazardous industrial waste from the Rio Tinto Kennecott Utah Copper facility. The public comment period on the draft permit modification begins July 31, 2020 and will end August 31, 2020.

Under Utah Code Section 19-1-301.5 a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the director to fully consider the substance and significance of the issue.
