Rio Tinto Kennecott Utah Copper submitted a permit application for the Tailings Refuse Class IIIb Landfill located on the Rio Tinto Kennecott Utah Copper Tailings Impoundment facility in Salt Lake County, Utah. The landfill will continue to receive non-hazardous industrial waste from the Rio Tinto Kennecott Utah Copper facility. The public comment period on the draft permit modification begins August 7, 2020 and will end September 7, 2020.
