The Director of the Division of Waste Management and Radiation Control invites public comment on a request from Rock Canyon Oil, LLC to modify its Used Oil Transporter Permit (UOP-0123). The Transporter Permit has been reformatted and updated to comply with recent regulatory changes to the Standards for the Management of Used Oil of the Utah Administrative Code and includes a new halogen determination method. The public comment period to receive comments on the permit modification will commence on October 16, 2017 and end on October 30, 2017.
