Salt Lake Valley Solid Waste Management Facility Solid Waste Permit Renewal

Salt Lake Valley Solid Waste Management Facility has requested to renew the permits for their Class I Landfill and Compost Facility located at 6030 West California, in Salt Lake City. The facility has been operating since 1993 and accepts municipal, commercial, industrial, and construction solid wastes. The Division of Waste Management and Radiation Control has reviewed their permit renewal application and has prepared a draft permit.

A 30-day public comment period to receive comments on the permit renewal will commence on Monday, October 24, 2022 and end at 5 p.m. on Tuesday, November 22, 2022.
