**NOTICE OF PUBLIC COMMENT
WHITE HILLS CLASS I LANDFILL**

Sanpete County has submitted an application to renew the permit for the White Hills Class I Landfill located south of Sterling, Utah. The proposed permit application has been reviewed and has been determined to be complete and in compliance with the Utah Solid Waste Permitting and Management Rules. This permit allows the facility to continue to operate the Class I landfill for ten years after the permit has been approved. The Director of the Division of Waste Management and Radiation Control is seeking public comment on the Draft Permit for the White Hills Class I Landfill. The public comment period to receive comments on the Draft Permit will commence on November 1, 2019 and end on December 2, 2019.
