The Director of the Division of Waste Management and Radiation Control is seeking public comment on a draft Solid Waste Permit for the Stericycle Tooele County Medical Waste Incinerator facility, located on the east side of the Rowley Road approximately 10.7 miles north of the I-80 interchange at Exit 77.
