The City of Santaquin has submitted a permit renewal application to continue operations of a Class IVb Landfill located within Utah County. The Permit application has been reviewed by the Division of Waste Management and Radiation Control for compliance with the Solid Waste Management Rules and a draft permit has been prepared. The Director is soliciting comments on the draft permit prior to final action by the Director.
