Trans-Jordan Cities has submitted a permit renewal application for their Class I Landfill located in South Jordan, Salt Lake County, Utah. Daily activity will be unchanged at the Landfill. The Permit application has been reviewed by the Division of Waste Management and Radiation Control for compliance with the Utah Solid Waste Permitting and Management Rules and a draft permit has been prepared. The Director is soliciting comments on the draft permit prior to final action by the Director.

A 30-day public comment period to receive comments on the permit renewal will commence on Monday, April 10, 2023 and end at 5 p.m. on Tuesday, May 9, 2023.
