The Director of the Division of Waste Management and Radiation Control (Director) is proposing to enter into Stipulation and Consent Order No. 2111118 with Tri State Oil Reclaimers, Inc. (TSOR) to resolve Notice of Violation and Compliance Order No. 2111115 without further administrative or judicial proceedings. TSOR shall pay a penalty of \$48,626.00 (forty-eight thousand, six-hundred and twenty-six dollars) as follows: pay a monetary penalty of \$24,313.00 (twenty-four thousand, three-hundred and thirteen-dollars), while the remaining penalty amount, \$24,313.00 (twenty-four thousand, three-hundred and thirteen-dollars) will be deferred and waived by the Director if TSOR complies with the Orders set forth in paragraphs 10.2 and 10.3 of the Stipulation and Consent Order.

A 30-day public comment period to receive comments on the Proposed SCO #2111118 for Resolution of NOV #2111115 will commence on January 8, 2024, and end at 5:00 p.m. on February 7, 2024.
