The Director of the Division of Waste Management and Radiation Control invites comment from the public on a draft Site Management Plan (SMP) developed by Varex Imaging, former Varian Medical Systems, located at 1678 South Pioneer Road in Salt Lake City, Utah. The SMP includes activity use limitations and future actions needed to manage the soil and groundwater contamination present at the site. The property is also required to implement an Environmental Covenant that will be recorded in the Salt Lake County Recorder's Office, after approval of the SMP.

The public comment period to receive comments on the SMP will commence on June 18, 2018 and ends on July 18, 2018. A public hearing may be held if, within 15 days of publication of this notice, a request is made to the Director in writing which meets the requirements of UAC R315-311-3.
