RCRAInfo is EPA's comprehensive information system, providing access to data supporting the Resource Conservation and Recovery Act (RCRA) of 1976 and the Hazardous and Solid Waste Amendments (HSWA) of 1984. The system enables cradle-to-grave waste tracking of many types of information regarding the regulated universe of RCRA hazardous waste handlers. RCRAInfo characterizes facility status, regulated activities, and compliance histories in addition to capturing detailed data on the generation of hazardous waste from large quantity generators and on waste management practices from treatment, storage, and disposal facilities.



### Who is a Hazardous Waste Generator?

"*Generator* means any person, by site, whose act or process produces hazardous waste identified or listed in Part 261 of this chapter or whose act first causes a hazardous waste to become subject to regulation."

### Who could be the Generator?




The owner/operator of the manufacturing process unit, product/raw material storage tank, transport vehicle, or vessel.



The owner of the product, raw material, or manufacturing material being stored that may generate a hazardous waste.



The person who removes hazardous sludge, sediments, or other residues from a manufacturing process unit, tank, vehicle, or vessel.



### Cogenerators

#### 3 Parties

- The owner/operator of the manufacturing process unit.
- The owner of the product, raw material, or manufacturing material being stored.
- The person who removes the hazardous waste from the unit.

#### Parties should agree

Where 2 or more parties
are considered to be
cogenerators, they should
mutually agree (by
contract or other means)
who will perform the duties
of the generator on behalf
of the other parties.

#### Joint & Several Liability

All cogenerators are legally responsible for the waste and enforcement action can be taken against any party that meets the definition of generator.
