# What is it?

Environmental justice is the <u>fair treatment</u> and <u>meaningful involvement</u> of all people

with respect to the <u>development</u>, <u>implementation</u>, <u>and</u> <u>enforcement of environmental laws</u>, <u>regulations</u>, <u>and</u> <u>policies</u>

and the equitable distribution of environmental benefits.



# What is it?

Fair treatment: no group of people bears a disproportionate share of negative consequences from industrial, governmental, and commercial operations or policies.



# What is it?

#### Meaningful involvement:

- People have an opportunity to participate in decisions about activities that may affect their environment and/or health
- \* The public's contribution can influence the regulatory agency's decision
- Community concerns will be considered in the decision-making process
- Decision-makers will seek out and facilitate the involvement of those potentially affected.





EPA established goal in 2022-2026 Strategic Plan to take decisive action to advance EJ concepts in programs, policies, and activities

UDEQ EJ committee DAQ applying for grants




### **Environmental Justice Populations**

- UDEQ still establishing thresholds likely 80%
- Indexes considered:
  - \* People of color
  - Low income
  - \* Unemployment
  - \* Language
  - Education level
  - \* Age
- \* Prioritize areas above the threshold for multiple indexes



  - holding additional public hearings in EJ communities
  - \* connecting with local groups in EJ communities
