The Director of the Division of Waste Management and Radiation Control invites public comment on a 10-year permit renewal of a Used Oil Marketer Registration for Emerald Services, Inc. The proposed modifications for Registration UOR-0077 would update its format as part of a ten-year review.

A fifteen-day public comment period to receive comments on the updated registration will commence on Thursday, February 1, 2024, and end at 5:00 p.m. on Thursday, February 15, 2024.
