REGISTRATION FORM - IN VITRO TESTING WITH RADIOACTIVE MATERIAL UNDER GENERAL LICENSE

R313-21-22(9) of the Utah Radiation Control Rules establishes a general license authorizing physicians, veterinarians, clinical laboratories, and hospitals to possess certain small quantities of radioactive material for in vitro clinical or laboratory tests not involving the internal or external administration of the radioactive material or the radiation therefrom to human beings or animals. Possession of radioactive material under this general license is not authorized until the physician, veterinarian, clinical laboratory, or hospital has filed form DWMRC-07 with the required \$20.00 registration fee, and received from the Division of Waste Management and Radiation Control a Certificate of Registration. Pursuant to R313-70-5(3)(a), a general license Certificate of Registration is valid for a period of five years provided the annual fee is paid.
