The Director of the Division of Waste Management and Radiation Control is seeking comment on a proposed modification to the Beaver County Class I Landfill Permit for an Alternative Final Cover for final closure of a portion of the Municipal Solid Waste Landfill. The permit modification request has been determined to be complete and compliant with the Utah Solid Waste Permitting and Management Rules.

The public comment period to receive comments on the permit modification will commence on March 30, 2017 and end on May 1, 2017.
