Bountiful City Corporation, Class I Landfill Permit Renewal SW103

Bountiful City Corporation has submitted a permit renewal application for their Class I Bountiful Sanitary Landfill located in Bountiful (Davis County). Daily activity will be unchanged at the Landfill. The Permit application has been reviewed by the Division of Waste Management and Radiation Control for compliance with the Utah Solid Waste Permitting and Management Rules and a draft permit has been prepared. The Director is soliciting comments on the draft permit prior to final action by the Director.

A 30-day public comment period to receive comments on the Bountiful Class I Landfill Permit Renewal will commence on Monday, May 8, 2023 and end at 5 p.m. on Tuesday, June 6, 2023.

All documents included in comments must be submitted in pdf format or as ASCII (text) files.

Under Utah Code Section 19-1-301.5 a person who wishes to challenge a Permit Order may only raise an issue or argument during an adjudicatory proceeding that was raised during the public comment period and was supported with sufficient information or documentation to enable the director to fully consider the substance and significance of the issue.
